

**Below is a list of Winter and Snow Emergency Parking Bans. This list is for reference only. If you have questions, please contact the appropriate city or town government.**

*In the event local governments deem a public safety emergency such as an early or late season snow storm occurring outside the below stated dates, your vehicle could still be subject to ticketing and towing if parked on city or town streets.*

## **AMESBURY**

### **Winter Parking Ban**

*Winter Parking Ban begins on: Monday, December 1 and lasts until April 1.*

*All vehicles must be parked off the street between the hours of 1:00 AM and 5:00 AM, regardless of weather conditions, to facilitate the storm operations of the Public Works Department. Any vehicle left unattended on the street will be subject to a parking violation and/or towing at the owner's expense. The winter ban violation fine is \$50.00.*

*Overnight parking is also prohibited in Public School and Municipal Parking Lots, including the Friend Street, Main Street, Water Street, Public Library and School Street parking lots.*

## **MERRIMAC**

### **Winter Parking Ban**

Per Merrimac Town Bylaw Article VI, Section XII: Motor vehicles are prohibited from parking in any street or highway for more than one (1) hour from 11:00PM to 6:00AM, from November 15th to April 1st.

## **NEWBURY**

### **Winter Parking Ban**

*Parking of vehicles on Newbury's streets is prohibited between midnight and 6:00 AM from December 1 to April 1. Any vehicle in violation of this restriction will be towed.*

## **NEWBURYPORT**

### **Snow Emergency Parking Ban**

*The City of Newburyport implements a snow emergency parking ban when it is felt that we are to receive three inches of snow accumulation. Parking regulations are strictly enforced to ensure streets remain accessible for snowplows, fire apparatus and other emergency vehicles. Any vehicle that impedes the snow removal process will receive a parking ticket and be towed.*

## **SALISBURY**

### **Winter Parking Ban**

*The winter parking ban goes into effect December 1st and lasts until April 1st. There is no on street parking from the hours of 12:00am, midnight to 6:00 am.*

### **Snow Emergency Parking Ban**

***There is no on-street parking during snow storms and snow removal efforts regardless of the time.***

*During snow emergencies temporary parking is available in the municipal parking lot at the beach in the metered section only.*

## **WEST NEWBURY**

### **Winter Parking Ban**

*Pursuant to West Newbury Town Bylaws: No person shall park any motor vehicle on any public way in the town overnight from December 1st until April 30th. The penalty for violation of this parking ban shall come under the jurisdiction of Chapter 90, Section 20A 1/2 of the General Laws imposing the maximum allowable fine for each offense.*
